Dear President Claudet:

My name is Nicholas Hillebran. Over a month ago I sent an email to you in regards to Terrebonne General Medical Center. It was my goal to attempt to get a matter resolved that has been going on for almost two years. Despite my personal efforts to clear my name with Terrebonne General Medical Center and Ms. Phyllis Peoples (CEO) I have been met with nothing but ill actions on their part.

I will give a brief summary of the issues and you may read the details (and evidence) on a website I have created. The website is dedicated to projecting the truth about Ms. Peoples and TGMC.

On January 2, of 2006 my employment at TGMC was terminated. The true reason was based upon false allegation that TGMC failed and refused to investigate. It was stated in a letter by TGMC to the Louisiana Department of Labor that two nurses relayed to administration that an ER Tech heard me say something to the equivalent of, "One day I'm going to come in here and shoot everybody one by one."

The two nurses passed this information along without validating it. TGMC acted swiftly and harshly on these actions without validating the statement. The fact of the matters are this:

- I never made any such statements or any statements that are even remotely akin to such morbid and psychopathic actions.
- Based upon an email communication between the ER Tech and I, the ER Tech stated to me that he never told those two nurses nor anyone the alleged statement I was terminated for.
- The statements by the nurses were taken as direct fact when they were nothing more than here say.
- Upon contacting Ms. Peoples about this, as well as other issues, I received a very insincere response. One that I feel was an attempt to simply brush me away.
- Upon posting what I know on the Internet and pushing the matter to be investigated, Ms. Peoples used scare tactics to silence me. The scare tactics included a threat of suit for harassment, libel, and slander. In addition, the attorney for TGMC sent a carbon copy of the letter to the St. Mary and Terrebonne Parish Sheriff's Offices. Had the Sheriff's Offices acted upon the lies told by Ms. Peoples I would have had legal right to file a complaint for filing a false police report.

To this date I have no knowledge of why Ms. Peoples has been so evasive and diabolical in handling this matter. I would imagined that someone in her position would be one of the first to have the desire to investigate a former employee being wrongly terminated. In particular, considering the fact that I was falsely accused of and treated as a terrorist (I was escorted off the property by the head of security as well as banned from returning to the property, even if family or friends were hospitalized there).

I decided to write to the Terrebonne Parish Consolidated Government as I had read of an individual whom contacted the TPCG previously challenging Ms. People's competence. It seems that when Councilman Wayne Thibodaux read the anonymous letter it upset Ms. Peoples. As a result, Ms.

Peoples started doing what she and TGMC do best, utilize scare tactics to attempt to silence any critics of herself or the organization. According to the article legal threats were made to any media outlet that published the contents of the letter.

There are a few differences between myself and that anonymous individual. First and foremost is that I am not anonymous. My full contact information is at the header of this letter if you wish to personally call me and validate any information or ask any questions you may have. Another difference is that I will not be silenced. I am not some disgruntled deranged former employee. I am very much educated and aware of my legal rights. Since Ms. Peoples prefers theatrics and drama over resolving matters, I created the website, www.tgmcrevealed.com to show the public the true side of Ms. Peoples and TGMC.

The website has my personal commentary as well as any correspondences I have sent to Ms. Peoples, correspondences I have received from Ms. Peoples, and any person or organization in connection with this matter. I am very familiar with the Internet and know that anyone can type up anything they want and claim it to be truth. It is for this reason that I have scanned all correspondences sent and received in regards to this matter. They are available for viewing on the website under the "Evidence" section in PDF format.

It is my hopes that you will look in to this matter. Not only is frightening and troubling to know that Ms. Peoples is the head of an organization that is held in such a high regard by the Terrebonne community but to know that this organization has the community's life in it's hands on a daily basis.

I do hope that this matter is looked in to. Because of an issue I had with Ms. Peoples (false claim of harassment), I will only send you this one letter. It is being sent via certified mail so that I can prove on the website that the letter was sent to you and received. If you choose to look in to this matter then I look forward to hearing from you. If you choose to ignore this matter, then it will be on your conscious to ignore such warnings about the unethical and immoral acts of Ms Peoples and TGMC.
